The 'Moving beyond Borders' exhibition explores the journeys of migrants and highlights the measures which are responsible for their perilous crossings of the Sahara, the Mediterranean Sea and the Eastern borders of the European Union.

This exhibition offers a multimedia representation of the contemporary migration situation.

This includes maps, to provide an overview of the routes people take and the way in which border control moves and is outsourced.

There are photographs to illustrate the consequences of a security-based approach to the migration issue, as observed in Europe and beyond.

Soundscapes – composed by the Étrange Miroir company which also designed the layout of the exhibition – accompany the various media.

The exhibition is made up of five interactive units, the first three dealing with contemporary facts, while the last show two imaginary and opposing scenarios of the potential development in European migration policy.
